You are invited to attend the National Association of Dairy Regulatory Officials (NADRO) Annual Meeting to be held July 14-17, 2019 at the Marriott Mystic in Groton, Connecticut.

Anyone with an interest in dairy regulatory issues is invited to attend—allied dairy industry representatives, dairy processor groups, dairy producer groups, dairy industry retirees, and dairy industry public officials. The group meets annually to discuss issues relevant to dairy regulatory matters, evaluate issues impacting the nation's dairy industry and to formulate recommendations to submit to federal agencies and national organizations. An excellent program is scheduled and all dairy industry professionals are invited to attend the meeting.

We ask that you also email your state report to Eunice prior to the meeting.

For Allied Industry: Allied industry representatives are encouraged to become Allied Members of NADRO . There are no voting rights associated with the membership; however, there are benefits that will get your company name/logo on the NADRO website, in the Annual Meeting proceedings and more.
